Together we make a stronger Idaho.

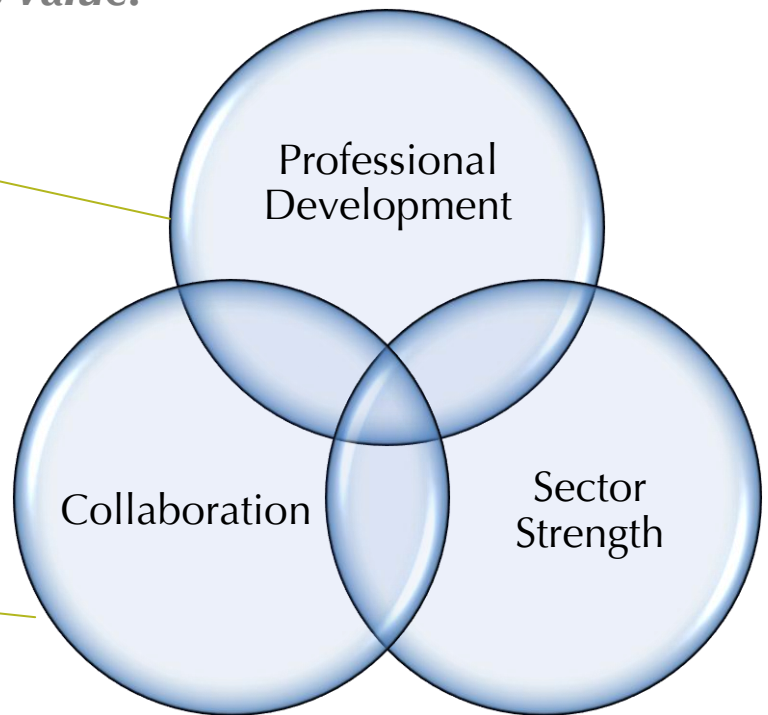

Membership dues are based on your annual operating budget. Member discounts are designed to offset the cost of joining:
